

# Instructor of Bagpipes (Visiting Music Instructor, up to two days per week)

The High School of Dundee is seeking to appoint an enthusiastic Instructor of Bagpipes to join its thriving and well-established Music Department from Monday 7 December 2020, or as soon as possible thereafter. The successful candidate will be expected to deliver the learning of practice chanter and bagpipes in one-to-one lessons, as well as assist the Pipe Major (Full-time) and Drum Sergeant (0.75FTE) in the training of ensembles involving Pipes & Drums or chanters. Additionally, there may be the opportunity to contribute to other co-curricular activities that the department offers.

### **The School**

The High School of Dundee was established in 1239. Today the School is a flourishing co-educational independent school for pupils aged 3 to 18. There are currently some 1,050 pupils at the School.

The School is situated in the city centre of Dundee, only ten minutes' walk from the railway station. Working at The High School offers the opportunity to be part of a vibrant and welcoming community, committed to academic excellence and the highest standards of pastoral care for its pupils. The development of excellence in the education offered to the pupils is the underlying purpose of activities undertaken by all staff.

The High School of Dundee is committed to the safeguarding and welfare of children and applicants must be willing to undergo child-protection screening appropriate to this post, including checks with past employers.

# The Post

The High School Pipes and Drums form part of the school's co-curricular Music programme and have a growing reputation for the high quality of their performing. The Instructor of Bagpipes should work in close collaboration with the Pipe Major with the aim of strengthening this reputation by thorough and effective rehearsal and tuition. He or she will need to teach chanter and bagpipes and prepare pupils for any school ensemble in which they take part, including the regular programme of public performances and external competitions.

The Instructor of Bagpipes will give individual lessons within the Music Department from L3 to F6, following our Pipe Major's Teaching Programme. Pupils may be presented for National 5, Higher and Advanced Higher Music examinations, both as course awards and as free-standing units. In addition, pupils may need to be prepared for PDQB exams.

The successful applicant should have an extensive knowledge of and be an expert practitioner in the bagpipes. In addition, he or she should be able to tune a Pipe Band and perhaps step in as pipe major of any school band if required. The successful candidate is likely to be required to be present at Pipe Band Competitions to assist tuning and preparing the High School Band(s). The successful candidate will be required to instruct theory of music as well as the other aspects of musicianship required for pupils to have a full understanding of the instrument, its practice and repertoire.

The ability to work as part of a large and enthusiastic team is essential.

## The Role

To provide pupils with a rounded musical education through the medium of the pupil's instrument and the range of the instrument's repertoire.

#### **Main Responsibilities**

- To instruct 30-, 45- or 60-minute music lessons to pupils as requested by the Director of Music.
- To set an example of high standards to pupils by demonstrating chanter- or bagpipe-playing in lessons as appropriate.
- To provide a considered programme of study tailored to each individual pupil that allows for continuity from lesson to lesson.
- To provide music lessons with a regularity that can be considered reasonable by the Director of Music; at least 30 regularly-spaced lessons should be instructed to each pupil each session.
- To ensure that each pupil is aware of his or her practice requirements for the next lesson and is following those requirements.
- To prepare pupils to perform in concerts and in other public events.
- To prepare pupils for PDQB, SQA and/or other public exams as appropriate.
- To write reports to parents or guardians at least twice a year on each pupil's progress.
- To speak with the parents or guardians of all pupils at the annual Music Parents' Evenings.

# **About the Music Department**

#### Staffing

The Music Department is currently composed of a Director of Music, three full-time academic teachers, eight full-time instrumental instructors, eleven visiting music instructors, and a Music Department Administrator. The academic teaching covers all school years from Ante Pre-school to F6, with Music an obligatory subject up to F2, taught by specialists throughout. The department offers instruction in all orchestral and band instruments, recorder, piano, guitars, organ and voice.

#### **Accommodation and Resources**

The department is currently housed in the Margaret Harris Building, and has: four academic classrooms (including an IT suite and sound-engineering room); an extensive library of scores, parts, CDs, DVDs and LPs; eleven rooms for individual music instruction; and one large rehearsal hall. In addition, the school has a performance hall with Yamaha C5 piano, and performs two major concerts per session in the Caird Hall, Dundee's civic auditorium and a premier recording venue for orchestral repertoire. The school is in the process of converting the adjacent disused Post Office Building into a new centre for the Performing and Visual Arts.

#### **Attainment**

The department enters approximately 150 pupils for ABRSM practical exams each session. Typical pass rates since 2012 are 99%, with 55% or candidates achieving Merit or Distinction. In SQA Music and Music Technology Exams at National 5, Higher and Advanced Higher, the department achieved a 100% rate of A grades (60% at Band 1) in the 2017 exam diet with 37 candidates. Since 2014, over 95% of pupils taking SQA Music exams have achieved an A grade.

#### **Activities and Concerts**

Approximately half of the pupils at the High School receive individual instructions on one or more instruments and voice. The following groups rehearse weekly: Symphony Orchestra, Sinfonia, Chamber Orchestra, String Sinfonietta, Little Heifetz and Tutti Strings; Symphonic Band, Concert Band and Big Band; Competition Pipe Band, F4-F6 Pipe Band, F1-3 Pipe Band, Junior Years Pipe Band; several Wind, Brass, Guitar and Percussion Ensembles; Cantabile, L6-7 Choir, L4-5 Choir, Girls' Choir and Boys' Choir. Chamber music includes a variety of string, woodwind and brass groups. Jazz is encouraged.

Among the wide range of performances, the larger ensembles of pupils perform at two major concerts each year in the Caird Hall. In 2019-20, the pupils performed (among many other pieces): Mozart's "Jupiter" Symphony, Corelli's "Christmas" Concerto, music from the film "Mary Poppins", music from Disney's "Frozen", Bon Jovi's "Livin' On A Prayer", and Lady Gaga's "Poker Face". In addition, we were preparing for a performance by pupils in F4-6 of "Grease" and a whole evening programme for our choirs, bands and orchestra based on a theme of "The Olympics", both of which were sadly cancelled due to the COVID-19 lockdown. There is a regular programme of evening concerts and weekly performance platforms, as well as two evening ensemble concerts in the summer. Concerts are given from time-to-time outside school, including an annual Festival of Nine Lessons and Carols at St Paul's Cathedral, Dundee. There is a house music competition and solo performance competitions. The Junior and Senior Years put on a musical alternately each year: "Aladdin" in 2019 by the Junior Years, and in 2018, "Fiddler on the Roof" by the Senior Years. Our Competition Pipe Band began the 2020 Competition season very promisingly with a second place in our category at the Scottish Schools' Pipe Band Championships before competitions ceased, and we entered a second band in the non-RSPBA section of the same competition.

Several of the school's pupils at any one time are members of the National Youth Orchestras of Scotland and the National Youth Choirs of Scotland. Former pupils include Ricky Ross of the band Deacon Blue, singer KT Tunstall, and classical pianist Christina Lawrie.

#### **Additional Information**
